MOBILE APPLICATION PRIVACY NOTICE CHARGE SAINT

PLEASE READ THIS NOTICE CAREFULLY

IMPORTANT INFORMATION AND WHO WE ARE

S4EV Ltd, a company registered in Scotland (Registered Company No. SC739047) and the owner of "Charge Saint" App, (we) are committed to protecting and respecting your privacy.

This notice (together with our End-user Licence Agreement (**EULA**) and any additional terms of use incorporated by reference into these documents) applies to your use of:

- "Charge Saint" mobile application software (**App**), once you have downloaded or streamed a copy of the App onto your mobile telephone or handheld device (**Device**).
- Any of the documentation and services accessible through the App (Services), unless
 the EULA states that a separate privacy notice applies to a particular Service, in which
 case that privacy notice only applies.

The App allows users to upload photographic evidence and other information of electric vehicle (EV) charge point parking infringements (**Submitted Information**). We send Submitted information to our customers who are electric vehicle charge point operators (**Operators**) and Local Authorities (**Authorities**) ("our Customers") in the UK. This allows our Customers to enforce parking restrictions.

This notice sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read this carefully. If you have any questions about how we process your personal data please contact support@chargesaint.com

OUR ROLE

For the purpose of Data Protection Law, we are the Data Controller of personal data collected from your use of the App. Any reference to the Data Protection Law means (while they remain in force and applicable in the UK) the Data Protection Act 2018, the UK General Data Protection Regulation (GDPR), and any other laws and regulations relating to the processing of personal data in the UK.

INFORMATION WE COLLECT FROM YOU AND HOW WE USE IT

We will collect and process the following data about you:

• Information you give us to register with the App (Contact Information): This is information you give us about you when registering to use the App or when you fill in a form on the App to report a problem. The information you give us may include your name, e-mail address and username.

Our legal basis for processing Contact Information to allow you to use the App is that it is in our legitimate interests as well as your legitimate interests in that it is necessary in order for you to use the App and for it to fulfil its purpose in addressing misuse of electric vehicle charging points.

- **Information we collect about you and your device.** Each time you use our Apps we will automatically collect the following information:
 - **Usage information.** Details of your use of our App. Our legal basis for processing Usage information is legitimate interest. It is important for us to understand how our App is being used so we can improve it; and
 - Location information. We use GPS technology to determine your current location and geo-tagged photographs you upload ("Geo-tagged Photographs"). This enables us to determine the location of the parking infringement. Our location-enabled Services require your coordinates, for the feature to work. If you wish to use the App, you will be asked to consent to your location being used for this purpose. The location-enabled Services are only monitoring your Device location when you are using the App. When the App is closed, or running in the background, we do not collect location information. You can withdraw your consent at any time by contacting us at: support@chargesaint.com or changing your location settings on your device.

DISCLOSURE OF YOUR INFORMATION

We will disclose the data we collect from you to the following third parties:

- If we are under a duty to disclose or share your personal data in order to comply with any legal or regulatory obligation or request.
- In order to:
 - enforce or apply the EULA, and other agreements you have agreed to with us or to investigate potential breaches; or

• protect the rights, property or safety of S4EV Ltd, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

WHERE WE STORE YOUR PERSONAL DATA

All information you provide to us is stored on secure servers in Ireland, which is deemed by the UK Government as having an adequate level of protection for personal data given it is part of the EEA. Where we have given you (or where you have chosen) a password that enables you to access certain parts of the App, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

HOW LONG WE WILL KEEP YOUR DATA FOR

We will retain your data for no longer than the purpose for which we require to process it to deliver the App.

You can ask us to delete your data: see Your Rights below for further information.

YOUR RIGHTS

You have the following rights:

- Where we rely on consent, you can withdraw your consent to us processing your data
 for use with the App at any time by contacting us at: support@chargesaint.com or
 removing the App from your device. Please note that if you do this you will no longer
 be able to use the App. Also any withdrawal of consent will not affect our processing
 up to the date of withdrawal.
- You have the right to lodge a complaint with the Information Commissioner's Office (ICO) if you think that we have infringed your rights. You can find more information about reporting a matter to the ICO at the following link: https://ico.org.uk/.
- You have the right to access information held about you. You can access your
 personal data and correct, update or delete it by accessing the App and making any
